The proposed changes, resulting from the comprehensive review, are intended to bring the City of Cambridge Official Plan into conformity with Provincial Policy, e.g. Provincial Policy Statement, and the Provincial Growth Plan as well as the Regional Official Plan (2010).

This notice is intended to make you aware of proposed changes and to invite your comments. No decisions will be made on the proposed changes to the Official Plan at the time of the Public Meeting. If you wish to be a delegation at the October 17, 2011 Public Meeting, it is advisable to contact the City Clerk at 519.740.4680 ext. 4233 before the meeting day. This office may also be reached by email at (clerks@cambridge.ca). If you have not contacted the City Clerk prior to 4 p.m. on the day of the meeting, you may ask the City Clerk for permission to speak prior to the start of the meeting.

If you wish to be notified of future Committee or Council meetings at which recommendations are to be considered, or if you wish to be notified of the adoption/refusal of the proposed official plan amendment, and you are not currently on the Official Plan Review mailing list, you must:

- sign the register provided at the upcoming public meeting for this purpose;
- or make a written request to the City of Cambridge Planning Services Department at P.O. Box 669, Cambridge, Ontario, N1R 5W8.

With the exception of the Public Meeting Notice, notice of the future meetings on this proposal will only be sent to those persons who have requested to be notified.

If a person or public body does not make an oral submission at a public meeting or make a written submission to the City of Cambridge before the proposed official plan amendment is adopted, the person or public body is not entitled to appeal the decision on the City of Cambridge Official Plan to the Ontario Municipal Board or be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to add the person or public body as a party.

The Regional Municipality of Waterloo is the approval authority for Official Plan Amendments. If you wish to be notified of the decision of the approval authority in respect to these applications, you must make a written request to the Regional Municipality of Waterloo, 150 Frederick Street, Kitchener, Ontario, N2G 4J3.
