TIM TUROW AWARD – OUTSTANDING ATHLETE OF THE YEAR GUIDELINES

1. Recipient must be participating in athletic capacity as opposed to coaching, managing, etc.
 2. The nominee must have the City of Cambridge as their principal residence or a prior Cambridge connection; having resided in Cambridge or participated as a member of a Cambridge Sports Team.
 3. There will be no restriction on age.
 4. There will be no discrimination between sexes.
 5. There will be no restriction on sport. The term “Sport” will include all sport activities recognized by Sport Ontario.
 6. There will be no restriction on caliber or level of competition.
 7. The degree of involvement in more than one sport is to be considered.
 8. Sportsmanship, behaviour and deportment are to be considered.
 - 9 The award is to be awarded at a maximum of once per year, but not necessarily every year.
- In the event of a tie, the Selections Committee has the option to choose more than one individual.

GEORGE HILL AWARD – TEAM OF THE YEAR GUIDELINES

1. The recipients must be participating in a local league, or representing the City of Cambridge in the league in which the team participates.
2. There will be no restriction on age.
3. There will be no discrimination between sexes.
4. There will be no restriction on sport. The term “sport” will include all sport activities recognized by Sport Ontario.
5. There will be no restriction on caliber or level of competition.
6. Sportsmanship, behaviour and deportment are to be considered.
7. There is to be no restriction on as to amateur or professional status.
8. The award is to be awarded a maximum of once per year, but not necessarily every year.
9. In the event of a tie, the Selections Committee has the option to choose more than one team.
10. A team is defined as more than two (2) persons.

There will be no more than a maximum of four (4) non-participating persons awarded a plaque.

PROFESSIONAL ATHLETE OF THE YEAR GUIDELINES

1. Recipient must be participating in athletic capacity, as a professional as opposed to coaching, managing, etc.
 2. The nominee must have a prior Cambridge connection; having resided in Cambridge or participated as a member of a Cambridge Sports Team.
 3. There will be no restriction on age.
 4. There will be no discrimination between sexes.
 5. There will be no restriction on sport. The term “Sport” will include all sport activities recognized by Sport Ontario.
 6. There will be no restriction on caliber or level of competition.
 7. The degree of involvement in more than one sport is to be considered.
 8. Sportsmanship, behaviour and deportment are to be considered.
 9. The award is to be awarded at a maximum of once per year, but not necessarily every year.
