Poor: <70% live crown. Poor vigor. One or more major structural or biological deficiencies or several moderate deficiencies and/or presence of major disease.	0.25
Dead/Hazardous: Tree has <10% live crown or has completely succumbed to deficiencies, or tree is an immediate risk to surroundings.	0.00
