**RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT:**

In consideration of approval to participate in the activity of **Skateboarding, scooter or BMX activity** at, Pipes and Rails Park I hereby agree as follows:

1. **To waive any and all legal claims** that I have or may in the future have against the Corporation of the City of Cambridge, its directors, officers, employees or agents, representatives or any person in any way connected with the Corporation (all of whom are hereinafter collectively referred to as (the releasees); to release the releasees from any and all liability for any loss, damage, injury or expense I may suffer, or that my next of kin may suffer as a result of my participation in **Skateboarding, Scooter and BMX activity**, due to any cause whatsoever including negligence, breach of contract, or breach of the statutory or other duty of care. I acknowledge my responsibility to ensure adequate medical, personal health, dental and accidental insurance coverage, as well as protection of my personal possessions.
